10-04-1 Opening worship

10-04-2 Recording Clerk *pro tem* named

10-04-3 Minutes from Meetings of 10-25-09 and 1-24-10

The minutes from Salem Quarter's meetings held the 25th of 10th month, 2009 and 24th of 1st month, 2010 were **approved** as presented.

10-04-4 Memorial Minute for John Barlow

10-04-5 Memorial Minute for Rosly Walter

10-04-6 Consideration of Annual Themes for Quarter Programs

At our meeting in October it was suggested that the Quarter set a theme for our programs over the course of a year (for the October, January and April meetings, in that order). The current practice of having the host meeting determine the program topic for each meeting means there is no continuity and as topics are repeated we tend to cover the same ground and not progress or deepen our understanding. Friends **approved** trying this for the coming October, January and April meetings.

10-04-7 Theme for the Coming Year's Programs

It was noted that, at this time, there did not seem to be a significant issue facing the Yearly Meeting which would need seasoning. Suggestions for possible themes for the coming year included building on discussions held during the Day of Extended Worship held a Wellesley Meeting; Earth Care Witness; or some other program aimed at leading to some form of action. Friends asked Quarterly Meeting Ministry and Counsel consider these and other topics and then determine the theme for the coming year.

Ministry and Counsel noted that the current Faith and Practice is unclear regarding who an individual holding a travel minute from their meeting with endorsements by the Quarter and Yearly Meeting is accountable to. They recommend that the Friend holding a travel minute report to the body originating the minute with copies forwarded to those bodies which endorsed the minute. Ministry and Counsel will forward this recommendation to the Faith and Practice revision committee.

At the Quarter's January meeting, Ministry and Counsel sponsored the program on Sexuality and Spirituality presented by Young Adult Friends. If needed, Ministry and Counsel is available to assist our constituent meetings as they take up this topic which has been referred to all meetings for discussion and discernment by Yearly Meeting.
